1. Purpose of the statement

3. Degree of compliance

The Company declares that it has developed and evaluated the electronic information interfaces related to its products and services, including its website, online customer relationship systems, electronic billing and administration functions, in accordance with the general and specific accessibility requirements set out in Annex 1 to the Act.

The compliance test covered the following:

- the machine readability of the website content, its usability with screen reader software,
- scalability of contrast ratios and text sizes,
- full keyboard navigation without the use of a mouse,
- provision of alternative access to visual and auditory information (e.g., image captions, readaloud options),
- logical structure, navigation consistency, and barrier-free user experience design,
- error handling, accessibility of forms, and barrier-free display of feedback.

The self-assessment and related development measures were carried out in compliance with WCAG 2.1 (Web Content Accessibility Guidelines) Level AA, taking into account the relevant legal and professional requirements. The Company is continuously working to ensure full compliance with all accessibility requirements.
